

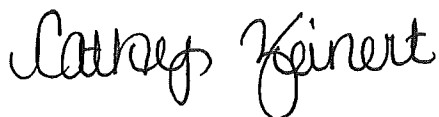
Chippewa Fire District Fire Commission Board Meeting Minutes
