FIRE CHIEF REPORT

District Safety Message

Heating, winter storms and candles all contribute to an increased risk of fire during the winter months.

- Heating is a leading cause of US home fires and home fire injuries and third leading cause of home fire deaths. Winter months are the peak months for heating fires. Space heaters are the type of equipment most often involved in home heating equipment fires, accounting for nearly one-third of the fires, as well as the vast majority of deaths and injuries in home fires caused by heating equipment.
- Candle fires peak in winter months with about 10 percent of candle fires in each of these months. Each year between 2020-2024, an average of 5,894 home candle fires were reported each year.
- Winter Storms, which can cause dangerous and sometimes life-threatening conditions. Blinding wind-driven snow, extreme cold, icy road conditions, downed trees and power lines can all wreak havoc on our daily schedules.

Home fires occur more in the winter than in any other season, and heating equipment is involved in one of every six reported home fires, and one in every five home fire deaths.
